NOTE TO ALL TRAVELLERS (BALI)

All Travelers to Bali Must Use the All Indonesia App

Starting 1 September 2025, all travelers entering Indonesia via major airports and ports — including Bali (Ngurah Rai Airport), Jakarta (Soekarno-Hatta Airport), Surabaya (Juanda Airport), and Batam's ferry terminals — must complete their arrival declaration using a new mobile app called All Indonesia.

The app is **mandatory for all travelers**, both locals and foreigners. It replaces older forms like the Satu Sehat Health Pass and the Electronic Customs Declaration, combining immigration, customs, health, and quarantine forms into one.

- ✓ Available in Bahasa Indonesia, English, and Chinese
- ✓ Can be filled in up to 3 days before arrival
- ✓ Aims to speed up and simplify the arrival process

Make sure to download and complete the All Indonesia app ([iOS](#) | [Android](#)) before flying into Bali or other listed entry points!

Visa Exemption Arrangement (VEA)

Travelers with passports from the following 13 countries do not require a visa to enter Bali. This is a single-entry visa valid for 30 days:

Brunei Darussalam • Cambodia • Lao PDR • Malaysia • Myanmar • Philippines • Singapore • Timor Leste • Thailand • Vietnam • Suriname • Colombia • Hong Kong

Visa Exemption Arrangement (VEA)

Passport holders from [97 countries](#) are eligible for Visa on Arrival (VOA). It costs IDR 500,000 (approx. USD 30.00) plus a service fee per person - IDR 150,000 (USD 10.00)* Visa on Arrival is for a single Entry into Bali/Indonesia, for a stay of up to 30 days, and can be extended for a maximum of 1 time at the local Immigration Office (charges apply). You can [apply and pay online](#) before arrival in Bali or pay and receive upon arrival in Bali.

* This fee helps fund environmental and cultural preservation initiatives across the island. Before arrival, you are encouraged to settle this payment via the [Love Bali Website](#) or the App. Be sure to check if you're exempt from the levy, as some categories of travelers, such as those in transit, may not need to pay. Upon payment, a tourism levy voucher will be sent via email, and the QR code can be downloaded to a smartphone or printed for scanning at checkpoints in Bali Airport and sea ports.

Pre-register for Bali's Autogates

All visitors intending to use the autogates must pre-register their passports online before arrival at the airport. You won't be able to pass through the gates if you skip this step. Pre-register for the autogates through the Indonesian [immigration e-visa portal](#).

Once completed, you may use the autogates on future trips to Bali without registering again. This makes the immigration process way faster than queuing at the manual counters.
